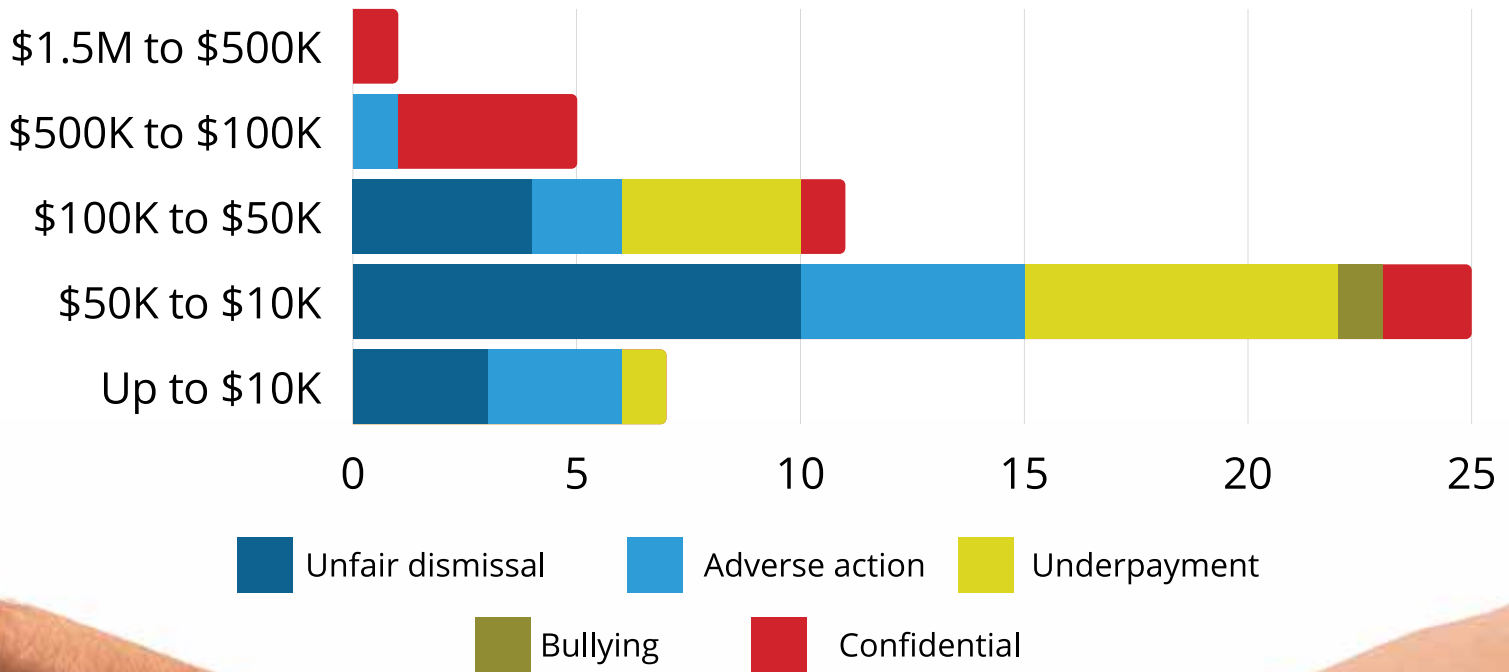

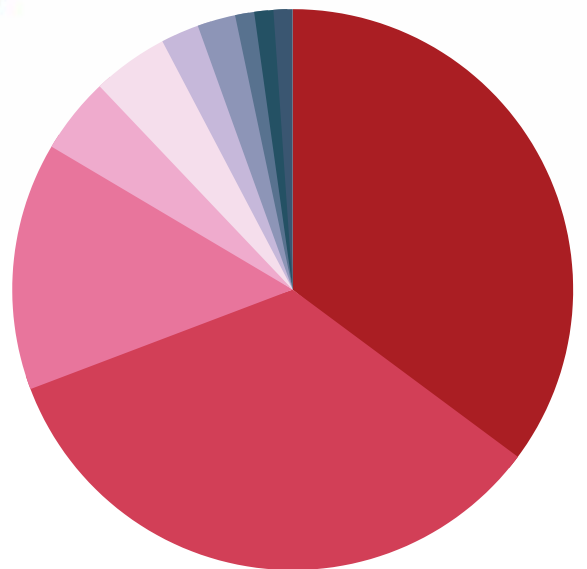
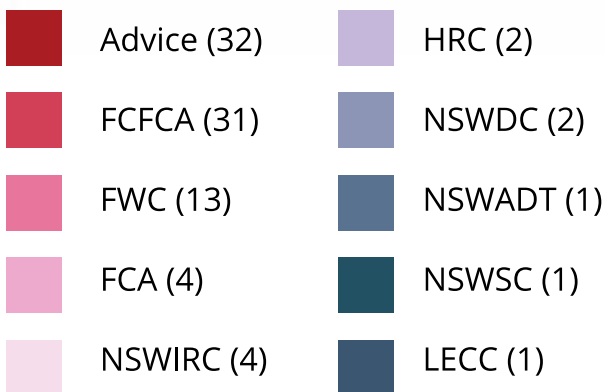
OUR RESULTS

In 2021, WorkLawyers gave advice to clients and/or had matters in the following venues.

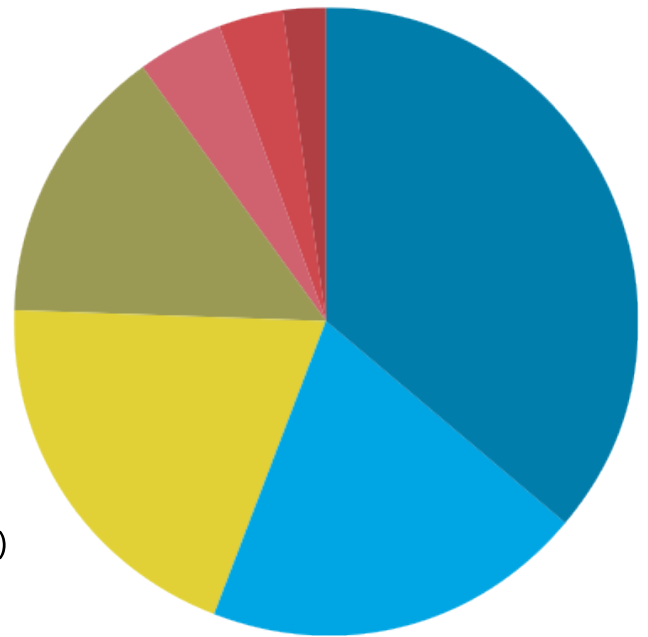
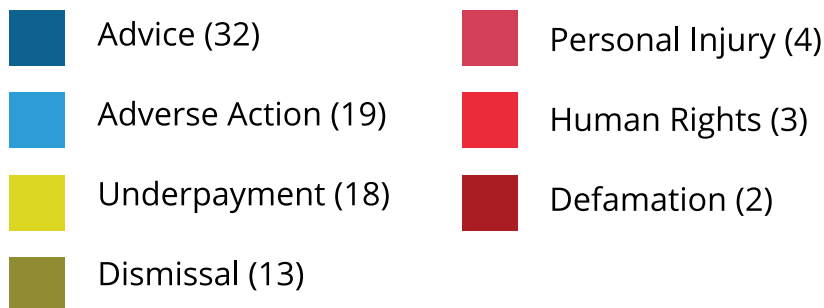
